### **YVAA's PUBLIC ART EXHIBITION PROGRAM**

Dear Yucaipa Valley Art Association Member,

Thank you for agreeing to show your art at Village Bread Calimesa. Your "show dates" will be for 3 months. There are two forms for you to fill out, with information that describes what is required to display art at this business. Both artwork and photography can be displayed. The art categories are broad, so please select art in your collection that will display well.

YVAA's member artwork will hang in Village Bread Calimesa's place of business or the main lobby. The wall will have 6 to 8 hanging wall cables, with one or two hooks on each cable. Artists can display up to a total of 2 pieces, depending on size. Large pieces can hang alone on a cable, and smaller pieces can be "stacked" two on a cable.

Applications are reviewed on a first-come, first-served basis and application completion does not guarantee the applicant an exhibition space. Please review the information included in the application forms. You can contact me if you have any questions. Once we have received your completed application forms, and photos of your artwork, your application will be reviewed and approved. Please provide a brief biography that will be used to create a tag or sign that will be displayed next to your artwork.

Your application should be submitted 3 weeks before the display exhibition date.

Thank you for being a part of YVAA's art program to display art in public places.

## **PUBLIC ART EXHIBITION PROGRAM INFORMATION**

Thank you for your interest in Yucaipa Valley Art Association's and Village Bread Calimesa "Public Art Exhibition Program". Please note that the purpose of the Program is to showcase YVAA's art and photography which may include a variety of subjects as portrayed by local artists. All interested artists must complete and submit this Artist Application to Yucaipa Valley Art Association (YVAA) Member YVAA Board Member for display of their artwork.

To submit, please email a completed application with high resolution (300 DPI) image as JPEG or PNG, and a completed Hold Harmless Agreement to [yvaacontact2@gmail.com](mailto:yvaacontact2@gmail.com) or turn in to YVAA at the monthly art show meeting at the Scherer Center.

1. Application submission deadline: **February 16, 2026.**
2. The Public Art Exhibition will be on display for three (3) months from **03/02/26 to 06/01/26**
3. Accepted artists will be notified by **February 25, 2026.**
4. YVAA's Public Art Exhibition Program will display artwork, including photography created by local artists that are members of YVAA. Applicant must be a current member of YVAA.
5. Each applicant may enter up to *two (2)* submissions.
6. Height and width of each piece is not to exceed 36" (including any framing) with a maximum depth of up to 8"; 10 lb. maximum per piece.
7. Work may include imagery of licensed or copyrighted characters. All imagery and references must be appropriate for all ages. YVAA reserves the right to accept or reject artwork submitted for public exhibition.
8. Artwork must have been created or photography taken by artist. No A.I. artwork or elements allowed.
9. Accepted piece(s) must be completely dry upon submission to YVAA and Village Bread Calimesa. All artwork pieces must be ready to hang by wire for wall display.
10. Accepted pieces will need to be handed in at Village Bread Calimesa by **Monday, March 2, 2026** between the hours of **12:30 pm to 2:30 pm**. YVAA's Art Exhibition Manager will be onsite to handle the intake of artwork.
11. Artwork to be picked up by artist on **Monday, June 1<sup>st</sup>, 2026** at Village Bread Calimesa between the hours of **12:30 pm and 2:30 pm**.
12. Any artwork not picked up by the artist three days after the pickup date, will be transferred and picked up by YVAA for storage until arrangements can be made with artist for pickup.

YVAA will coordinate with Artist for the pickup of artwork at Village Bread Calimesa at the end of the specified date. Artwork left on wall after the specified pickup date will be removed and stored for 3 days by Village Bread Calimesa. YVAA will be notified and artwork that has not been picked up by Artist may will be placed in temporary storage offsite and arrangements will be made for the Artist to pick-up their artwork at a different time and location.
